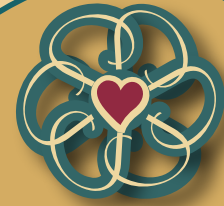

Further, I, on behalf of myself and my assigns, heirs, executors, guardians and other legal representatives, release, discharge, waive and forever relinquish any actions or causes of action whatsoever which may later arise, and I agree that under no circumstances will I or my assigns, heirs, executors, guardians and other legal representatives, prosecute or present any claims against, sue or seek to attach the property of Camacho (including Camacho's agents, employees, officers or directors), and that I waive all actions, claims or demands that I now or hereafter may have, for any injuries suffered by me during my participation or involvement in the reading and/or healing, resulting from any acts or omissions of Camacho, or any agent, employee, officer or director of Camacho, or resulting from the acts or omissions of any other participant in the reading and/or healing.
